«Alternativ mottaksplass»

"Alternative mottaksplass" – an alternative to staying in a reception center

"Alternativ mottaksplass" means that a municipality takes on the responsibility of providing necessary financial support and follow up individuals who are staying temporarily in private residencies. Provided that the UDI and municipalities accept the application, the municipality will receive financial contributions from the UDI.

Who does this arrangement apply to?

This extended arrangement applies to people from the Ukraine who are in the target group for temporary collective protection and who are staying temporarily in private residencies.

In order to receive "alternativ mottaksplass", the individual must have found a place to stay in a municipality. The following are examples of different arrangements:

- staying with family members who are settled in a municipality
- staying with other people who have offered a place to stay
- staying in accommodation provided by non-government organizations or the municipality



Cont. "Alternativ mottaksplass"

Individuals on the scheme «alternativ mottaksplass» are entitled to receive information, advice and guidance from the municipality.

The municipality will offer kindergarten free of charge for children aged 1 - 6 years old. NB! Only for this scheme.

Individuals on the scheme have the same right to receive health services as the rest of the population, and they are also entitled to receive care services.





The introduction programme

What is the introduction programme?

The introduction programme is a training programme intended to prepare you for participation in Norwegian working life. All refugees between 18 and 55 years of age who arrive in Norway shall participate in the introduction programme. The same applies to family members who arrive in the country at a later date.

The introduction programme shall commence as early as possible and no later than three months after you are settled in your municipality.

The introduction programme is a full-time programme.



What will the introduction programme contain?

Norwegian language

 All participants shall learn the Norwegian language. Your teacher shall establish a goal for your training in Norwegian language. This Norwegian language goal depends on your previous schooling.

Norwegian society

 All participants shall also learn about Norwegian society. This training is intended to make it easier for you to participate in society.



Cont. What will the introduction programme contain?

Mastery of life in a new country

 All participants shall participate in the course "Livsmestring i et nytt land" (Mastery of life in a new country). This course is intended to make it easier for you to make good choices in Norway and influence your own situation. You will also learn how you can receive help when needed.

Parental guidance

• If you have or are expecting children, you will also receive parental guidance. Through this guidance, you will learn what it is like to be a parent in Norway and what services are available for you and your children.



Cont. What will the introduction programme contain?

- The introduction programme will also include content that is adapted to you and your goals. This may involve unpaid participation in working life or education. Many participate in working life and in education during the time they are part of the introduction programme.
- You and your programme advisor shall jointly draw up a plan for the content of your introduction programme and its duration.
